Terms & Condition:

1. The School Managing Committee which is / will be constituted as per the guidelines of Education Department Notification vide No.F.10(28-12)-DSE/88, dated 16th May, 1990 and should be approved by the Board and if not approved immediately, it should be approved within next 06(six) months from the date of affiliation.
2. If the number of B.Ed teachers is less than five, the school authorities are required to engage the balance no. of B.Ed teachers during this period. Otherwise, further extension of affiliation will not be done.
3. The affiliation recognition is accorded purely on a Provisional basis.
4. There shall be sufficient accommodation for teaching and other purpose, play ground for Physical Education, requisite equipments for Science and organizing Work Education etc. classes, separate sanitation arrangement for male and female staff and students.
5. The School must have at least one pucca room for the Headmaster and his office.
6. The School must have adequate teaching staff possessing requisite qualifications as laid down by the Board from time to time.
7. There should be at least one teacher in each subject.
8. The pupil-teacher ratio should not be less than 20:1 for classes IX & X.
9. All rules of Admission/Examination and other affairs of School Administration as approved by the Board from time to time shall have to be strictly followed by the School.
10. The School should adhere to the principles laid down by the Board for normal functioning.
11. All guide-lines of the Tripura Board of Secondary Education in Academic matters shall have to be followed.
12. The School shall have to be inspected properly by the Education Department and detailed reports thereon to be submitted to the Board. The application for extension of affiliation along with the detailed report should be submitted to the Board through the Director of School Education, Govt. of Tripura, Agartala at least 3 (three) months before the expiry of the period for which the affiliation/recognition has been accorded by the Board.
